1. Project overview

PEPE WALL STREET 2.0 was born after many investors got tired of:

PEWS20 combines:

 - automatic on-chain raffles
 - investor-protection mechanisms
 - future expansion to staking and multichain bridge

2. Project mission

Build a meme project that:

- ✓ is transparent
- ✓ has fully auditable contracts

- ✓ uses multisig wallets
- ✓ has locked liquidity
- ✓ includes real team vesting

Without:

- ✗ unrealistic promises
 - ✗ guaranteed profits
 - ✗ “magic shortcuts”

3. Project security

Liquidity locked for 12 months

After listing:

- LP will be locked
- no withdrawal possible
- public lock link will be shared

Result:

- 🛡 protection against rugpulls
- 🛡 prevents sudden liquidity removal
- 🛡 increases market confidence

Liquidity built already during presale

Part of presale purchases is automatically directed to LP:

- dedicated wallet
- public
- fully traceable
- starts filling even before launch

4. Multisig on main wallets

Wallets secured by multiple signatures:

- owner multisig
- LP wallet
- team wallet

Benefits:

- ✓ no single person controls everything
 - ✓ reduced human risk
 - ✓ protection against device compromise
 - ✓ transactions require multiple approvals

5. Team vesting

Team tokens:

- are locked
- unlocked gradually
- over 12 months

Result:

- ✓ long-term alignment
 - ✓ protection against immediate dumping
 - ✓ institutional-level credibility
-

6. Token fees

Buys: **0%**

Transfers: **0%**

Sells: **3% total**, distributed as:

- 1% liquidity
- 1% marketing
- 1% buyback

Fee applies only on sells

No fees on buys

Nothing hidden in the contract

7. Presale structure

- ✓ 20 automatic rounds
- ✓ Chainlink BNB/USD price feed
- ✓ automatic round switching
- ✓ no hidden admin panel
- ✓ no manual price control

A round advances when:

- the tokens allocated to that round are sold out

Tokens are sent **immediately** after purchase.

No waiting for presale to end.

No “manual claim” weeks later.

8. First 500 buyers benefit

Simple rule:

- first 500 buyers: no minimum purchase
- after 500 buyers: minimum purchase = 20 USD

Important notes:

- ✓ early buyers do not get lifetime privileges
- ✓ rule applies equally to everyone after 500
- ✓ this is not a pyramid system
- ✓ no referrals required

Everything is on-chain and public.

9. Automatic raffles

For every **200,000 USD raised**:

- 🎁 automatic raffle
- 🏆 1 winner receives 1 BNB
- 🔗 randomness powered by Chainlink VRF

Features:

- ✓ impossible to manipulate
- ✓ random number is public

- ✓ blockchain-auditable
 - ✓ complete transparency

10. Tokenomics

Total supply:

₪ 1,000,000,000,000 PEWS20
(1 trillion)

Distribution:

- Presale: majority of supply
- Liquidity + Marketing: 20%
- Team: 12-month vesting

Simple summary:

- buyers receive tokens instantly
 - team cannot dump on market
 - LP cannot be removed

11. Official presale rounds

Parameters

- 20 rounds
 - starting price **\$0.00005**
 - approximate increase **+25% per round**
 - decreasing tokens per round
-
